# 1. Aims

- To provide the DEFRA soils and Peatland team with an overview of the needs for peatland restoration in Yorkshire and the benefits it will bring to society.
- To showcase the work being done by Pennine PeatLIFE and the Yorkshire Peat Partnership (including the use of GIS technologies and sophisticated mapping techniques)
- To better understand DEFRA's aims and objectives, and to find synergy with the peatland programme
- To build a good, open and productive working relationship between the DEFRA team and the peatland team
- To openly discuss all the challenges facing peatland restoration and potential solutions – including changes within DEFRA's own policy
- To outline the funding needs of peatland restoration
- To bring clarity to the above through a site visit to one of Yorkshire's most degraded sites, Fleet Moss.

## 2. Overview

The visit started with a presentation given by Tim Thom at the YPP offices in Skipton. The presentation provided a background to the work of the Yorkshire Peat Partnership and the Pennine PeatLIFE project.

Jenny Sharman followed with a presentation on Fleet Moss, illustrating the issues the team is trying to resolve, and describing the current negative impacts of the site on surrounding catchments. The presentation further focussed on the ecosystem services the site could provide once restored.

The day was finished off with a dinner for the group where further productive discussions were carried out.

On the second day of the visit, the team were taken onto Fleet Moss and shown the different problems facing unrestored sites. Several discussions followed, most particularly an interest in working out a means to continue to support peatland restoration - potentially with funding going towards monitoring. Awareness was raised regarding the current failings of the Countryside Stewardship scheme, and the funding gap that will be left following the withdrawal of the UK from the EU.

It would appear the meeting and follow ups have helped inform and develop DEFRA's England Peatland strategy.
